The meetings of All Unions and Associations of BSNL (AUAB), held on 26.06.2018 and 04.07.2018, discussed in detail about the non-implementation of the assurances given by the Hon'ble Minister of State for Communications, to the representatives of the All Unions and Associations of BSNL, in the meeting held on 24.02.2018, on the issues of implementation of 3<sup>rd</sup> Pay Revision to BSNL employees, implementation of Government of India Rules on payment of Pension Contribution by BSNL and the allotment of 4G spectrum to BSNL, as per the proposal submitted by the BSNL Management and Pension revision for the BSNL pensioners.

The meeting expressed it's deep concern that there is inordinate and unwarranted delay in the implementation of the assurances, given by the Hon'ble Minister of State for Communications, on the issues stated above. Hence, it has been decided to call on the BSNL employees, to organise the following agitational programme, demanding implementation of the assurances given by the Hon'ble Minister of State for Communications, without further delay.

### **Agitational programme**


- (1) ***Demonstrations in front of the BSNL Corporate Office, CCA offices at all circles and at SSA levels on 11.07.2018.***

Demand


Immediate implementation of the assurances given by the Hon'ble Minister of State for Communications, on the issues of
