Sub: - **Dishonouring of the commitment given on the floor of the National Council - req.**

Ref: - (1) BSNLEU letter no.BSNLEU/518 (PHONE) dated 19.12.2017.

In the 35th National Council meeting held on 13.11.2017, the Secretary, Staff Side, demanded that the Rs.429/- Mobile Plan be extended to the Non-Executives of BSNL also. The Chairperson of the National Council was kind enough to accept the demand of the Staff Side, and assured that the Plan would be extended to the Non-Executives.

This demand was raised in the National Council meeting due to the simple fact that a mobile tariff plan made available to almost all the customers, could be made available to the employees of the Company also. It is also an indisputable fact that, both the Company, as well as the employees would be benefitted due to this. This is in view of the fact that, presently the Company is spending Rs.200/- per month to recharge the SIM already provided to the Non-Executives.


Two reminders were given to the Management, vide letters cited under reference, demanding implementation of the decision of the National Council. However, to our astonishment, we were informed by the Admin Branch, vide letter no.2-22/2002-PHA(Pt.) dated 08.03.2018, that Rs.429/- Plan could not be extended to the Non-Executives. Various lame excuses are given in that letter, with a view to deny our demand raised in the National Council meeting.

In our letter, cited under reference (2) above, we have demanded that the Management could even introduce a "tailor-made" plan to it's Non-Executives, which is equivalent to the Rs.429/- tariff plan. It is very strange to note that the Management is not willing to consider the demand of the employees, even when the Company is not expected to incur any extra expenditure on this count.

In view of the foregoing, we wish to once again seek your intervention on this issue, to ensure that the commitment given to the Staff Side on the floor of the National Council, by the Chairperson, is honoured.
