Sub: - **Recruitment of Management Trainees in BSNL - req.**

We wish to bring the following important issue to your kind notice, for favour of necessary action.

Vide letter No.74-1/2015-Rectt. dated 30.04.2015, BSNL had issued notification for the recruitment of Management Trainees, both Internal and External. Subsequently, the conducting of the above recruitment, both Internal and External, were postponed. Thereafter, nothing is heard from the Management with regards to the above mentioned recruitment of the Management.

BSNL is presently being managed by the ITS officers, who are on deputation to the Company. It is an undeniable fact that a major section of these officers on deputation, will be retiring within the next 2 to 3 years. The question arises as to who will manage the Company in future. The Company will be facing a disastrous situation, if timely action is not taken to recruit the officers who will become the future managers of the Company.

BSNL Employees Union has all along been insisting that the Company should recruit its own future managers. We felt very happy when the Management announced the recruitment of Management Trainees. Unfortunately, it appears that this recruitment is kept in cold storage once for all.

The issue of allowing Non-Executives to appear in the MT exam, had been discussed in the 15th National Council meeting held on 13th July, 2007. Based on the discussions, the RR was revised and the Non-Executives, with the requisite qualification, were also made eligible to appear the exam. However, subsequently, the RR was amended by which, the eligibility of the Non-Executives to appear the MT exam was taken away. We took up the issue again in the National Council meeting that held on 23.04.2014 and it was assured that it would be re-examined. Nothing is heard thereafter, regarding the amendment of the RR of MT exam.

It is very pertinent to mention that thousands of young, aspiring and talented DR JTOs and DR JEs are eagerly waiting to appear in the exam. Hence, we once again demand that the Recruitment Rules of the Management Trainee Exam should be amended, so as to allow the Non-Executives with the requisite qualification also to appear in the exam. We also demand that the Management Trainee Exam, both for the Internal and External candidates, should be conducted without further delay.
