Com. Chandeshwar Singh, Chairman, AUAB, welcomed everyone and presided over the meeting. Com. P. Abhimanyu, Convenor, AUAB, briefly explained about the agenda items. The meeting reviewed the programmes organised by the AUAB, against the taking over of ALTTC, by the DoT. The meeting also seriously deliberated on the issue of non-settlement of Pay Revision of the Executives and Wage Revision of the Non-Executives, as a result of which a large number of employees are suffering from Stagnation. The meeting also made indepth discussion about the HR policy being followed by the Company, in pursuance of which outsourcing of works is being done massively, rendering a large number of employees redundant. After indepth discussions, the meeting took the following decisions unanimously:-

- (1) To write a letter, addressed to the Secretary, Telecom and CMD BSNL, demanding immediate settlement of Pay Revision of the Executives and Wage Revision of the Non-Executives.
- (2) One circular is to be sent to the employees, signed by all the General Secretaries, for creating awareness about the pending issues, serious involvement of all, the need of strongest unity and to motivate them for participating massively in the programmes for which call will be given by the AUAB.
- (3) To write a letter to the MPs of the Parliamentary Committee on Communications, as well as to the MPs of the Standing Committee on Communications.
- (4) To write a letter to the CMD BSNL, on the HR policy being pursued by the Management.
