Sub: - <u>Issuing notice for organising day-long black badge wearing and lunch hour demonstration on</u>

17.08.2022, against VRS, increasing of working hours, etc. – reg.

BSNLEU will be organising Day-long Black badge wearing and Lunch Hour Demonstration throughout the country on 17-08-2022, on the following issues / demands.

- 1) Stop implementing one more VRS, to retrench 35,000 employees, as envisaged in the presentation made to the HOCC, held at New Delhi, on 4<sup>th</sup> and 5<sup>th</sup> August, 2022.
- 2) Do not increase the working hours of employees. Threatenings, as contained in the letters of CGM, Rajasthan and PGM, Jalandhar, to increase the working hours to 10 hours / 12 hours per day, should be stopped forthwith.
- 3) Do not make the employees as scapegoats for the failures of the Government and Management, such as failure to launch BSNL's 4G service, etc. Stop the threatenings of dismissing the employees under FR 56(J).
