



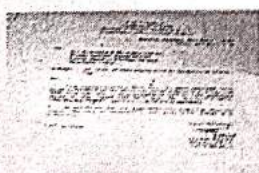

Sub: - Notification for organising hunger strike on 18.02.2021 - req.

It is hereby notified that BSNLEU will be organising a hunger strike throughout the country on 18.02.2021. The BSNL Management is harassing the employees for the past one year, by not disbursing the salary on the due date. Apart from this, there is inordinate delay in the settlement of the HR issues of the Non-Executives. For example, the non-holding of the various Limited Internal Competitive Examinations has shut-down all the avenues of promotions of the Non-Executives. Further, the BSNL Management is brazenly violating the guidelines issued by the DoT, vide its letter no.F.62-2/2016-SU dated 27th April, 2018, on the matter of Wage Revision of the Non-Executives. Hence, BSNLEU will be organising one day hunger strike throughout the country, on 18.02.2021, demanding settlement of the following issues: -

- (1) Ensure disbursement of salary on the due date of every month.
- (2) Ensure the immediate holding of the JTO LICE, JE LICE, JAO LICE, JTO (OL) LICE, TT LICE and Special JTO LICE for Draughtsmen.
- (3) Implement the direction of the DoT in respect of Wage Revision of the Non-Executives and immediately resume the negotiations for wage settlement.
- (4) Ensure payment of medical bills of the serving and retired employees. Ensure hassle-free cashless treatment in the empanelled hospitals.
- (5) Re-engage the retrenched contract workers and clear payment of their wage arrears.
- (6) Review the outsourcing of landline and broadband works through the SLA system.
- (7) Lift the ban on Compassionate Ground Appointments.
- (8) Do not deny presidential Orders to those Non-Executives recruited by the DoT, but joined duty after 01.10.2000.
- (9) Provide FTTH connections to the Non-Executives at 50% concession and without any ceiling (please refer to our letter no.BSNLEU/518(PHONE) dated 29.09.2020).

The All India Centre meeting of BSNLEU, held on 06.02.2021 has decided to intensify the agitations, if the demands are not settled.
