Dear Comrades.

10th All India Conference to be held on 07th, 08th & 09th March, 2022.

The Central Executive Committee meeting of BSNLEU, held at Hyderabad in August, 2021, has decided to hold the next All India Conference of BSNLEU at Guwahati, in the month of March, 2022. This will be the 10th All India Conference of our great organisation. In accordance with the CEC decision, action is being taken to hold the All India Conference at Guwahati. The All India Centre meeting held online on 29.11.2021, has decided that the AIC shall be held on 07th, 08th & 09th March, 2022. As usual, the pre-AIC CEC meeting will be held on 06th March, 2022. Notices for the All India Conference and the CEC meeting will be issued in due course. In BSNL, 50% of the employees have already gone on VRS. As a result, the membership of the Union has also got reduced proportionately. In view of this, the Hyderabad CEC meeting has decided that, the strength of delegates for admission in the 10th All India Conference will be 50% of the delegates admitted in the last All India Conference, held at Mysuru. Based on this decision, the All India Centre will finalise and inform about the number of delegates who will attend the AIC from each circle.

Holding the circle and district conferences.

Since the All India Conference is to be held in March, 2022, all the circle conferences which have already become due, should be conducted immediately. The circle secretaries are requested to contact the General Secretary and get the dates for the circle conferences. Similarly, the circle unions have to ensure that all the district conferences, which have become due, are conducted immediately.

Restructuring of BSNL's manpower.

After the implementation of the VRS, the BSNL Management undertook the task of restructuring of BSNL's manpower. BSNLEU has submitted it's views regarding the requirement of future manpower in the various Non-Executive cadres, as well as the Executive cadre of JTO, which is the promotive cadre for Non-Executives. The Management had declared that the Sr.TOA and ATT would be Dying Cadres. However, due to the timely intervention of BSNLEU, Management has agreed that, both these cadres would continue to remain as Live Cadres. Ultimately, the BSNL Board has approved the Restructuring of manpower and the Corporate Office, vide it's letter No.4-02/2021-Restg. dated 23.11.2021, has circulated it to the CGMs. This letter carries the number of JEs, Sr.TOAs (JOA / SOA / OA), Telecom Technicians / Assistant Telecom Technicians allotted for each circle. The circle secretaries are requested to look into this and to give their views to the CHQ.

Holding the conventions on National Monetisation Pipeline.

The last Central Executive Committee meeting held online on 17.10.2021, has decided to organise an effective campaign against the National Monetisation Pipeline (NMP). It is decided that all the circle unions should organise their circle level as well as district level conventions against the National Monetisation Pipeline. So far, only the circles of Kerala, West Bengal, Karnataka, Telangana and Odisha have conducted this convention. Maharashtra, Tamil Nadu and Chennai circles have fixed the dates for the convention. However, other circle unions have not decided about holding the convention. CHQ requests all the remaining circles to immediately hold this convention.

Wage Negotiations resumed.

As per the agreement reached between the AUAB and the CMD BSNL, the Wage Negotiation Committee is reconstituted and the Wage Negotiations have resumed. Two sittings of the Committee, i.e., on 18.11.2021 and 03.12.2021 have taken place so far.
