Sub: Selection of health insurer for providing "HEALTH INSURANCE SCHEME 2021" for BSNL employees –Regarding .

A Committee was constituted by the Competent Authority for giving its recommendations about a suitable health insurance policy for BSNL employees.

The scheme is voluntary and its premium shall be paid by the concerned BSNL employees. To implement the scheme willing BSNL employees will submit their option through ERP portal.

Based on the deliberation in the Committee, quotations were invited from Four Govt Insurance Companies namely New India Assurance Company Ltd, United India Insurance Company Ltd, National Insurance Company Ltd and Oriental Insurance Company Ltd. The quotations were called for two categories i.e. for Rs 5 Lakh insurance cover and Rs 10 Lakh Insurance cover. Rs 5 lakh health insurance is for all employees whereas Rs 10 lakh health insurance is for employees having E5 and above scale of pay. Both having a further option of top up of equal amount i.e. Rs 5 Lakh and Rs 10 Lakh respectively.

The quotations were opened on 08.12.2021 in which three quotes have been received from three Insurance companies namely New India Assurance Company Ltd, United India Insurance Company Ltd, and Oriental Insurance Company Ltd. The lowest offer has been submitted by the Oriental Insurance Company Ltd. The details of the TOR/ Terms and Conditions and the rates quoted by lowest quotationer (Annexure 'A' & 'B') are attached herewith.

It is requested to submit your views / comments on the same so that BSNL Management will take decision for the implementation of the health insurance policy for BSNL employees. The views/ comments may be submitted by 13.12.2021 positively.
