## Co-ordination Committee of BSNLEU, AIBDPA and BSNL CCWF

Dear Comrades.

A meeting of the Coordination Committee (CoC) of BSNLEU, AIBDPA and BSNLCCWF was held online on 4th June, 2022. The following comrades participated in this meeting.

BSNLEU: - Com. P.Abhimanyu, GS & Convener, CoC and Com. John Verghese, Dy GS.

AIBDPA: - Com. K.G. Jayaraj, GS & Chairman, CoC.

BSNLCCWF: - Com.V.A.N. Namboodiri, President and Com.Animesh Mitra, SG.

Com K.G.Jayaraj, Chairman presided over the meeting. Com. P. Abhimanyu, Convenor, welcomed everyone and briefed on the agenda items. Detailed deliberations took place on many important issues and the following decisions are arrived at.

- 1) A Human Chain is to be organised on 07-07-2022, demanding:
  - a) To immediately stop the handing over BSNL's 14,917 mobile towers and optic fibre to the private, in the name of National Monetisation Pipeline.
  - **b)** To drop the National Monetisation Pipeline.
  - c) To stop disinvestment/ privatisation of the Public Sector Undertakings.

This human chain program will be organised for one hour. The CoC decided that, the timing of this human chain programme will be decided at the circle level, depending upon their convenience. It is also decided that the CoC will prepare a pamphlet which has to be printed by the circle level CoCs and to be distributed among the general public.

- 2) To celebrate the 75th anniversary of Indian independence, by organising seminars and special meetings. The role played by the Indian working-class in the freedom struggle shall be highlighted. This celebration will start on 11th July, 2022, the date on which the historic strike of the P&T workers started in 1946 and will get concluded on 15th August, 2022.
- 3) AIBDPA has given call for the following agitational programmes, demanding settlement of Pension Revision and other demands. The CoC endorsed this call and decided to successfully organise these programmes which are as follows:-22-06-2022: Demonstrations. 20-07-2022: Dharna. 24-08-2022: March to Sanchar Bhawan.
- **4)** BSNL CCWF has given call for agitational programmes, demanding settlement of the problems of the casual and contract workers. The CoC endorsed this call and decided to successfully organise the programmes, which are as follows:-

27-06-2022: SSA level demonstrations.

30-06-2022: demonstrations at CGM offices.

5) The AUAB has given call for agitational programmes, demanding settlement of 3<sup>rd</sup> Pay Revision / Wage Revision, as well as other important demands of the Executives and Non-Executives. The CoC meeting decided to fully support all these programmes.
