Sub: - **Decision of the Central Executive Committee meeting, on the appeal submitted by Com.Bashir Ahmad Khan, Ex. Circle Secretary, BSNLEU, J&K circle – req.**

Ref: - **Appeal of Com.Bashir Ahmad Khan, dated 23.01.2021.**

I wish to convey the following decision of the Central Executive Committee meeting of BSNLEU.

The All India Centre of BSNLEU has placed Com.Bashir Ahmad Khan, under suspension for a period of six months and has also directed him to hand over the charge of the circle secretary to the first assistant circle secretary of J&K circle. Com.Bashir Ahmad Khan, vide his letter dated 23.01.2021 has submitted an appeal to the Central Executive Committee meeting, against the disciplinary action taken on him, by the All India Centre of BSNLEU.

The Central Executive Committee of BSNLEU, held at Chennai, from 07th to 09th March, 2021, looked into the appeal submitted by Com.Bashir Ahmad Khan, and has taken the following decision.

Based on the decision of the All India Centre, the CHQ, vide it's letter dated 11.12.2020, called for explanation from Com.Bashir Ahmad Khan. He was given 15 days' time to submit his explanation. However, Com.Bashir Ahmad Khan did not submit any explanation. Hence, the CHQ, vide it's letter dated 08.01.2021, reminded Com.Bashir Ahmad Khan to submit his explanation within seven days.

Thereafter, Com.Bashir Ahmad Khan, vide his letter dated 08.01.2021 stated that, his explanation would be given in the Circle Executive Committee meeting of J&K circle. The All India Centre meeting held on 13.01.2021, has decided to place Com.Bashir Ahmad Khan under suspension for a period of six months.

The Central Executive Committee meeting of BSNLEU, held at Chennai, looked into the appeal submitted by Com.Bashir Ahmad Khan. The Central Executive Committee meeting also looked into all connected correspondences / documents. The Central Executive Committee observed that Com.Bashir Ahmad Khan has continuously violated the decisions of the All India Centre and has also involved in activities, violating the Union Constitution.

All the efforts taken by the All India Centre to correct Com.Bashir Ahmad Khan, did not yield any result. And also, the long time, given by the All India Centre, to Com.Bashir Ahmad Khan, to correct himself was not utilised by him. Further, Com.Bashir Ahmad Khan did not even have the courtesy to submit his explanation to the All India Centre. This shows his arrogance and scant regard for the Union Constitution.

Under these circumstances, the Central Executive Committee concluded that the decision of the All India Centre to take disciplinary action against Com.Bashir Ahmad Khan is fully justified. However, the Central Executive Committee is of the opinion that, the disciplinary action taken by the All India Centre is not sufficient.

Hence, the Central Executive Committee meeting has unanimously decided to completely remove Com.Bashir Ahmad Khan from the post of Circle Secretary, BSNLEU, J&K circle and also to debar him from taking up union office bearer post at any level, for a period of one year. Further, the Central Executive Committee meeting directs the Acting Circle Secretary to hold the J&K circle conference by 31.05.2021.
