Sir,

Sub: - <u>Demanding withdrawal of the arbitrary increase in the JE training qualifying marks and also abolishing the differentiation existed between OBC, OC and SC/ST candidates - reg.</u>

Ref: - Junior Engineer (T) Induction Training Procedure (LICE Candidates) issued by ALTTC, Ghaziabad on 23.03.2023.

With reference to the above, we would like to emergently bring the following to your kind notice for favour of intervention and necessary action.

Vide letter cited under reference, the ALTTC, Ghaziabad, has prescribed Training Procedure for JE Induction Training of Junior Engineers. In para 1.7, captioned **Qualifying Marks**, it is stated that, the Qualifying Marks for JE training qualifying exam shall be 50%. This decision of the ALTTC, Ghaziabad, is arbitrary and will create severe strain and immense hardship for the trainees.

It will not be out of context to mention here that, so far the Induction Training Qualifying Marks for various categories of candidates were as follows:-

- (1) Qualifying Marks for OC candidates 35%.
- (2) Qualifying Marks for OBC candidates 30%.
- (3) Qualifying Marks for SC/ST candidates 20%.

From the above details it could be seen that, the Management had judiciously fixed the Qualifying Marks for various categories of candidates. However, the ALTTC, Ghaziabad, has now arbitrarily abolished the differentiation that had been laid down in the Qualifying Marks for the OC, OBC and SC/ST candidates. This action of the ALTTC, Ghaziabad, is against the OBC and SC/ST candidates.

Increasing the Qualifying Marks of the OC candidates to 50% is an injustice. Making it applicable for the OBC and SC/ST candidates also, is nothing but a crude joke.

In view of the foregoing, we earnestly, seek your kind and immediate intervention on this matter, and to ensure that, the earlier qualifying marks of 35% for OC candidates; 30% for OBC candidates and 20% for SC/ST candidates, are allowed to be continued. Since the training of the present batch is going to be completed on 19-05-2023, we fervently appeal to you to kindly make emergent intervention on this issue.
