With reference to the letter cited above, we wish to bring the following to your kind notice, for favour of necessary action.

BSNLEU is continuously drawing the attention of the Corporate Management to the fact that, the DR JEs who have applied for transfer under Rule-8 are not able to get the same. BSNLEU has taken up this issue as an agenda item, to be discussed in the forthcoming Formal Meeting, to be held with the Director (HR), (item no.8).

BSNLEU under took the exercise of finding out the number of DR JEs who have applied for Rule-8 transfer, after completing the stipulated five years of service. We are surprised to know that, as many as 56 DR JEs want to go on transfer under Rule-8, to their home circles, but are unable to get the transfer.

It is needles for us to mention that all these officials have applied for the transfer under compelling domestic circumstances. It has also been brought to our notice that, the transfer applications of many DR JEs have not even been forwarded to the circle office, by their controlling officers.

We have enclosed herewith, the list of DR JEs working in various circles who have applied for transfer under Rule-8, but not able to get it. All these officials are entitled to go on transfer under Rule-8. We strongly feel that, the Management should find out ways and means to mitigate the sufferings of all these officials.

In view of the foregoing, we earnestly urge upon you to kindly look into this matter and to do the needful, so that the transfer of the officials, whose names are mentioned in the enclosure, get their transfers without further delay.
