Sub: - **Difficulties experienced by the employees with regards to the TT LICE – requesting to kindly consider taking necessary remedial actions - reg.**

We wish to bring the following to your kind notice for favour of necessary action.

The Limited Internal Competitive Exam for the cadre of Telecom Technician (TT LICE), under 50% Internal Quota, for the vacancy years 2020 and 2021, was held on 27.08.2023. The result of this TT LICE have been declared now.

As we have already brought to your kind notice, the candidates desirous of appearing in the TT LICE have suffered from two setbacks.

Firstly, the TT LICE held on 27.08.2023, was held as an online exam. As we have already well explained in our earlier letters, the ATTs and other Group 'D' employees who appeared in the TT LICE have no knowledge at all regarding computer operation. Secondly, in a good number of circles, there was no vacancy for the TT LICE held on 27.08.2023.

In view of the difficulties experienced by the candidates desirous of appearing in the TT LICE, we earnestly appeal to you to kindly ensure holding the TT LICE as an "offline" examination.

As you are very well aware, in the entire period of existence of BSNL, no direct recruitment has been made in the cadre of Telecom Technician. Even here after, there is absolutely no scope of making any direct recruitment in the cadre of Telecom Technician. In view of this, the Main Recognised Union of BSNL is fully justified in demanding that the Direct Recruitment quota posts in the cadre of Telecom Technician should also be diverted to the Internal Quota.

Hence, we earnestly urge upon you to kindly divert the 50% Direct Recruitment quota post to the Internal Quota and to hold the TT LICE for the vacancy years 2020 and 2021 once again.

The aforementioned two steps, to be taken by the Management, will go a big way in mitigating the difficulties being faced by the candidates, desirous of appearing in the TT LICE. We once again request you to kindly consider these demands.
