Sub: - Notice for General Strike on 8<sup>th</sup> January, 2020 – req.

In accordance with the provision contained in sub-section (1) of Section 22 of the Industrial Disputes Act 1947, we hereby give you notice that we have called a strike from 6.00 A.M. on 08<sup>th</sup> January, 2020 to 6.00 A.M. on 09<sup>th</sup> January 2020, on the following demands.

### Demands:

#### Part - A

- 1) Take immediate actions to control price rise.
- 2) Control unemployment through employment generation.
- 3) Take strict actions against violation of labour laws.
- 4) Do not amend labour laws in favour of employers.
- 5) Ensure minimum wage of Rs.21,000/-.
- 6) Stop disinvestment / privatisation of Public Sector Undertakings.
- 7) Stop contractorisation – ensure equal pay for equal work to contract workers.
- 8) Ensure minimum pension of Rs.10,000/- p.m. for the entire working population.
- 9) Remove ceilings on payment of bonus, provident fund & increase quantum of gratuity.
- 10) Implement ILO conventions C 87 and C 98 – register trade unions compulsorily within 45 days of applying.
- 11) No FDI in Railways, Insurance and Defence.
- 12) Universal social security cover for all workers.

#### Part - B

- (i) No privatisation / disinvestment of BSNL.
- (ii) Implement 3<sup>rd</sup> Pay Revision to BSNL employees w.e.f. 01.01.2017.
- (iii) Extend financial assistance to BSNL for the expansion / upgradation of BSNL's networks and compensation for loss making rural services.
- (iv) Revision of pension to BSNL retirees w.e.f. 01.01.2017.
- (v) Ensure 30% Superannuation Benefits to BSNL's Directly Recruited employees.
- (vi) Payment of salary to BSNL employees on due date by BSNL / DoT.
- (vii) Ensure payment of wages to contract workers.
