Sub: - **Holding of JTO (Civil / Electrical) Special LICE to filling 50% vacancies from Draughtsman (Civil / Electrical) cadres - reg.**

Ref: - (i) Decision of the 28th meeting of the National Council held on 30th January, 2013 on item no.8.2.14.
(ii) Decision of the 35th meeting of the National Council held on 13th November, 2017 in item no.14.

We wish to bring the following to your kind notice, for favour of appropriate action.

In the 28th National Council meeting held on 30th January, 2013, against item no.8.2.14, the Union demanded for one more JTO (Civil / Electrical) Special LICE to fill up 50% vacancies from Draughtsman who could not appear in the exam conducted in the year, 2008, as they had not completed 10 years service at that time as per RR for JTO (Civil / Electrical).

Management Side replied that "the case for grant of one more chance for Draughtsman (Civil / Electrical Telecom) to appear in JTO (Civil / Electrical) was considered by Director (HR) and it was agreed to give one more opportunity to Draughtsman cadre on the similar lines as given a previous occasion. The case is under active consideration by the Branch for seeking approval by the competent authority."

The said decision of the National Council has not been implemented even after many years, despite the union has given many letters.


Thereafter, the union re-opened the item in the 35th National Council meeting held on 13th November, 2017, vide item no.14. The Management Side replied that the proposal was kept pending by the BSNL Board for finalisation of BSNL HR plan. Finally, the Management Side has agreed that proposal should not be linked with the HR plan and the case seeking approval for conducting of Special LICE for the left out draughtsman for promotion to JTO (Civil) would be examined by Establishment Branch.

Surprisingly, the said decision of the National Council has also not been implemented even after one year has been passed. We are at loss to understand how many times the Union has to approach the Management, for the implementation of a decision that has been taken at the highest negotiating forum.

In view of the foregoing, we request you to kindly intervene in the matter, so that the notification for the JTO (Civil / Electrical) LICE to fill up 50% vacancies from Draughtsman cadre is issued without further loss of time.
