In modification of this Department's O.M. of even No. dated 07.10.2019, the rate of DA payable to the executives and non-unionized supervisors of CPSEs (2007 pay revision) is as follows:

a) **Date from which payable:** 01.01.2020

b) **Average AICPI (2001=100) for the quarter Sept., 2019 – Nov, 2019**

Sept., 2019	322
Oct. 2019	325
Nov., 2019	328
Average of the quarter	325


c) **Link Point:** 126.33 (as on 01.01.2007)

d) **Increase over link point:** 198.67 (325 minus 126.33)

e) **DA Rate w.e.f. 01.01.2020:** 157.3% $[(198.67 \div 126.33) \times 100]$

2. The above rate of DA i.e. 157.3% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.Ms. dated 26.11.2008, 09.02.2009 & 02.04.2009.

3. All administrative Ministries/ Departments of the Government of India are requested to bring the foregoings to the notice of the CPSEs under their administrative control for necessary action at their end.


