Sub: - Implementing the order of the Hon'ble CAT, Chandigarh Bench, in the OAs No.1089/2017 and No.856/2017 delivered on 08th August, 2025 – req.

Sir,

We wish to bring the following to your kind notice on the subject mentioned above.

The Hon'ble CAT, Chandigarh Bench, in its order delivered on 08th August, 2025, in the OAs 1089/2017 and 856/2017, has directed to treat the applicants as DoT recruitees. The Hon'ble CAT has also directed the respondents to grant the applicants the status of DoT recruitees, resulting in extension of the benefits and service conditions, including GPF, old pension scheme, family pension, gratuity, LTC, leave encashment, medical facilities and promotional avenues as are applicable to the DoT employees absorbed in BSNL after 01.10.2000.

The Hon'ble CAT has also ordered that the judgement should be implemented within 3 months of the date of receipt of a certified copy of this order. In this connection, we wish to further state that, the recruitment process of all the applicants in the aforementioned OAs started with the notification issued by the DoT dated 22.07.2000, for filling up 687 vacancies of TTAs in Punjab Telecom Circle. The last date for submission of applications was 17.08.2000.

All the applicants in the aforementioned 2 OAs are presently working in various BAs / OAs in Punjab circle. All the applicants approached the Hon'ble CAT, praying to treat them as DoT recruitees. The Hon'ble CAT, accepted their prayer and has quashed the impugned order dated 03.07.2017.

We request that, the aforementioned order of the Hon'ble CAT may kindly be implemented without delay. We are enclosing you a copy of the aforementioned order of the Hon'ble CAT for favour of your kind information.
