Sub: - **Inordinate delay in the relieving of JEs on Rule-8 transfer – case of NE-1 circle – requesting for your kind intervention - req.**

We wish to bring the following to your kind notice, for favour of necessary action.

As you are aware, BSNLEU is continuously taking up the Rule-8 transfer cases of DR JEs. Especially, some difficulties are being experienced in NE-I circle, which we have already brought to your kind notice.

As of now, accommodation is already received from the circles to which 8 DR JEs have applied for Rule-8 transfer. The letters for accommodation are received from the respective 8 circles more than a month ago. However, the NE-I circle administration has not relieved the 8 DR JEs to their circles for which transfer has been applied.

Since this delay, on the part of the NE-1 circle administration is causing unnecessary mental agony to the officials who have sought transfer, we request you to kindly intervene in this matter and to ensure that the DR JEs are relieved from NE-1 circle without further delay.
