Sir,

Sub: - Issuing of Presidential Orders to the TSMs who were directly promoted as Telecom Technicians – inordinate delay in the settlement of the case - requesting to once again take up the issue with the DoT - req.

We wish to bring the following to your kind notice for favour of necessary action.

BSNLEU is continuously taking up the case of around 400 officials, for whom Presidential Orders are yet to be issued. This case is lingering on for a long time. These are the officials, who were conferred with Temporary Status prior to the formation of BSNL. After formation of BSNL, they were directly promoted as Telecom Technicians. BSNLEU is demanding that, Presidential Orders should be issued to all these officials, on the analogy of the TSMs who were appointed as Regular Mazdoors, after 01.10.2000 and were issued with POs.

After doing much spade work, BSNL sent the file to the DoT, for issuing of Presidential Orders to all the aforementioned 400 and odd Telecom Technicians. However, after keeping the file for a pretty long time, the DoT has returned the same to BSNL. This is a great injustice to the officials who are rightfully entitled to get Presidential Orders and consequential benefits.

It may be recollected that, it is BSNLEU which originally raised the demand that, Presidential Orders should be issued to all the TSMs appointed as Regular Mazdoors, after 01.10.2000. The logic of our demand is that, 50% of the TSM service should be counted for pension, according to the Temporary Status Scheme, implemented by the DoT in 1989. BSNLEU pointed out that, unless these officials are not made entitled for Government Pension, the question of counting their 50% TSM service for pension, does not arise. This logical argument of BSNLEU was accepted by the DoT and Presidential Orders were issued for thousands of TSMs, who were regularised after 01.10.2000.

The 400 and odd Telecom Technicians, who were originally issued with Temporary Status, prior to the formation of BSNL, also fall under the above mentioned category. Our submission is that, the DoT has returned the file to BSNL, without proper application of their mind. Many TSMs who have directly been promoted as Telecom Technicians are retiring. They will be deprived of their Government Pension, if justice is not rendered immediately.

In view of the foregoing, we urge upon you to kindly once again take up this issue with the highest level in the DoT, for find an early solution.
