Sub: - **Issuing of Presidential Orders to the Temporary Status Mazdoors, who directly became Telecom Technicians, without getting regularised as Regular Mazdoors - reg.**

Ref: - (1) BSNLEU letter no.BSNLEU/511 (Rectt.) dated 11.11.2020
(2) BSNL F. No.6-1/2021-LE (RTI) dated 05.02.2021

We wish to bring to your kind notice, the case related to the issuing of Presidential Orders to around 400 Temporary Status Mazdoors, who have directly been promoted as Telecom Technicians.

The Casual Mazdoors, who had been working in BSNL and who were conferred with the Temporary Status, prior to 01.10.2000 and who were subsequently regularised and appointed as Regular Mazdoors, on or after 01.10.2000, were already issued with Presidential Orders. This decision has been taken by the DoT, in view of the fact that, as per the Temporary Status Scheme, 50% of the service rendered as "Temporary Status Mazdoor" should be counted for calculation of pension.

In this connection, it has been brought to our notice belatedly that, such of those Casual Mazdoors who had been conferred with the Temporary Status, prior to 01.10.2000 and who were directly appointed as Telecom Technicians, without getting regularised as Regular Mazdoors, have not been issued with the Presidential Orders.

Based on the Temporary Status Scheme of the DoT, if 50% service rendered as Temporary Status Mazdoor is to be counted for calculation of pension, then Presidential Order should also be issued to the Temporary Status Mazdoors who were directly promoted as Telecom Technicians. BSNL Employees Union took up this issue with the BSNL Management, as far back as in the year 2015. In the 32nd meeting of the National Council, held on 14.05.2015, this issue was taken up. The minutes for this meeting was issued on 06.07.2015, wherein it has been assured by the Management that, the details of this case would be collected from the circles and would be taken up with the DoT, for the issuing of Presidential Orders.

Now, it is informed by the BSNL that, the Corporate Office, vide it's file number 11-1/2015-LE (Pt.) has sent the case to the DoT, with the approval of the CMD BSNL, for taking a final decision on the matter. In view of this, we implore upon you to kindly get the matter examined and cause to issue Presidential Orders to the TSMs who got directly promoted as Telecom Technicians, on the analogy of the TSMs who were appointed as the Regular Mazdoors on or after 01.10.2000.
