Sub: - **JAO LICE – 2016 conducted in Himachal Pradesh circle without carrying forward the unfilled SC vacancies of the JAO LICE conducted in the year 2012 – requesting to address the grievance of the affected SC candidate – reg.**

With reference to the letters cited above, we wish to bring the following to your kind notice for favour of necessary action.

Vide the two letters cited under reference, we have already brought to your kind notice that, the JAO LICE (40% quota), for the vacancy year 2016, has been conducted in Himachal Pradesh circle, without carrying forward the vacancies of the SC category, which remained unfilled in the JAO LICE conducted in 2012. We have also pointed out that, due to this lapse on the part of the Management, an official by name Shri Vivek Kanwar, belonging to the SC category has been deprived of his JAO promotion.

It is going to be 6 months now, since the issue was taken up with the Management. In the meanwhile, the General Secretary of BSNLEU, has also personally discussed this issue 2/3 times with the GM(Pers.), Corporate Office. However, it is regrettable to note that, the Management has not taken any action on this issue.

Such inaction on the part of the Management only projects it in a very poor light. We hope that, due action will be taken by the Management at least hereafter. The earlier two letters written by BSNLEU on the subject, are enclosed for your kind perusal.

With reference to the letter cited above, we wish to bring the following to your kind notice.

Vide letter cited above, we have drawn your kind attention to the JAO LICE (40% quota) conducted in Himachal Pradesh in the year 2016. We have pointed out that, this examination had been conducted without carrying forward the unfilled vacancies of the JAO LICE conducted in 2012.

In the JAO LICE conducted in the year 2012, two SC posts remained unfilled. These posts were not carried over to the LICE conducted in the year 2016. An official named Shri Vivek Kanwar has claimed that, he would have got selected as JAO, had the two unfilled posts of the year 2012 been carried forward for the JAO LICE conducted in the year 2016. The details are once again given in the following table:-

Sub: - JAO LICE – 2016 conducted in Himachal Pradesh circle without carrying forward the unfilled SC vacancies – requesting to address the grievance of the affected SC candidate – req.

We wish to bring the following to your kind notice, for favour of necessary action.

The JAO exam, under 40% LICE, was conducted in the year 2016. A candidate, by name Vivek Kanwar, belonging to Mandi SSA, Himachal Pradesh circle, appeared in this exam and passed in it. The official belongs to SC category. There were only 5 vacancies in SC category. Based on marks obtained, Shri Vivek Kanwar got 6th position. Hence, the 5 SC candidates who obtained more marks got selected as JAO.

It has belatedly been brought to our notice that, in the JAO examination conducted in Himachal Pradesh circle, in 2016, the unfilled SC vacancies of the earlier period, were not carried forward. As per our information, 2 unfilled SC vacancies, which remained unfilled in 2012, existed at that time. But, unfortunately, the JAO LICE 2016 was not conducted by carrying forward these 2 unfilled SC vacancies. Had the JAO-2016 exam been conducted by carrying forward those 2 unfilled vacancies, definitely Shri Vivek Kanwar would have got posting as a JAO. The details of the unfilled JAO vacancies of Himachal Pradesh circle, that were carried forward / not carried forward, are given below. It clearly shows that, 2 vacancies which remained unfilled in 2012 exam, were not carried forward.

Even though this case relates to the JAO LICE conducted in 2016, it is clear that injustice has been done to an SC candidate. In view of this, we earnestly urge upon you to kindly review this case, by calling for the necessary details from Himachal Pradesh circle and to render justice to the affected SC candidate.
