Sub: - **Requesting to release the JAO RR after necessary amendments and also to conduct JAO LICE immediately - req.**

Ref: - (i) BSNLEU letter no.BSNLEU/527(JAO) dated 24.06.2016.
(ii) BSNLEU letter no.BSNLEU/527(JAO) dated 13.06.2018.

Kindly refer to the letters cited under reference, vide which we have already drawn your kind attention to the subject.

In the 34th meeting of the National Council, held on 10th March, 2016, the Staff Side strongly demanded the removal of the stringent conditions of the JAO Recruitment Rules 2001, viz., 5 years of service in the 9020-17430 pay scale the upper age limit of 53 years and also the cut off date for reckoning the 5 years residency period as of 1st January of the vacancy year. Following the discussions in the National Council, we have demanded, vide letter cited under reference (i) and (ii) for the amendments to the JAO Recruitment Rules 2001 and to conduct the JAO LICE.

We were informed by the Management that the draft JAO RR with our proposals for amendments are sent for the approval of the appropriate authority. However, even after an agonising delay, the JAO RR is yet to be amended.

Further, we wish to bring your kind notice that the last JAO 40% LICE was held on 17.07.2016. Thereafter, no exam was conducted, on the plea that the RR is under approval and the LICE would be held after the amendments are incorporated in the JAO RR.

The issue was discussed with the Director (HR), Sr.GM(EF) on many occasions but no solution to the problem has come. There is a severe resentment among the aspiring candidates, due to the inordinate delay in holding the JAO LICE.

In view of the foregoing, we request you to kindly look into the matter and to cause to issue necessary instructions to release the amended JAO RR without further loss of time and also to conduct JAO LICE at the earliest.
