Sub: **-Injustice faced by JTO LICE aspirants in the exam for vacancy year 2017-18 held in 26.05.2019- giving full marks for wrong / multiple / answers /out of syllabus - req.**

We wish to draw your kind attention to the subject mentioned above for favour of necessary action.

The 50% JTO LICE for the vacancy year 2017-18 was originally scheduled to be held on 28.04.2019, but was postponed. Finally the exam was held on 26.05.2019. The officials with Diploma in Engineering are eligible to appear the LICE. However, in this exam, many questions have been asked, which do not form part of the syllabus. It is reported by a large number of candidates who appeared in the above stated exam that, many of the questions asked in the examination are of GATE level.

The provisional answers keys have been published on 01.06.2019. Further, the Management has notified for the first time that, ***the candidates can launch their grievances for wrong / ambiguous questions through official grievances portal, and for each wrong/ ambiguous question, a candidate needs to pay Rs.100/.*** It is very surprising that, the management has introduced a new provision for one of the departmental exam without any consultation with the recognised Union. We strongly object such type of action from the Management to its own employees.

Now, after scrutinising the answer key, several discrepancies are observed. It has been noticed that 6 questions in part A and 9 questions in part B are found with wrong or with multiple correct or ambiguous answers, 22 questions in part B are found out of syllabus or beyond Diploma Engineering standard. Candidates have already represented for review of such types of questions.

In view of the foregoing, we request you to kindly intervene in the matter and to ensure to grant full marks to the questions with wrong / multiple / ambiguous answers / out of syllabus. Further, it is also requested that marks should be given to the questions which are beyond Diploma Engineering standard. We are enclosing details of wrong/ multiple/ ambiguous or out of syllabus questions for your kind perusal.
