Subject: Limited Internal Competitive Examination for promotion to the grade of JTO(T) under 50% internal quota for vacancy year 2021 (Calendar year) for vacancies upto 31.12.2021-reg.

The undersigned is directed to convey the approval of the Competent Authority for holding of LICE (Limited Internal Competitive Examination) for promotion to the post of JTO(T) under 50% internal quota for the Vacancy Year 2021. The LICE for JTO(T) for the vacancy year 2021 shall be conducted as per provisions laid in the Recruitment Rules of JTO(T) 2014 issued vide this office letter no. 5-32/2013-Estt-IV dated 14.10.2015.

The competent authority has approved 913 vacancies for LICE for JTO(T) in 18 circles as per Annexure-A [Enclosed]. Hence, LICE for JTO(T) under 50% internal quota for the vacancy year 2021, as per the provisions of JTO(T) RR's 2014 for vacancies upto 31.12.2021 may be conducted as per details given below:

- a. The LICE will be held as per the scheme and syllabus circulated vide this office letter of even No. dated 20.10.2009 and modified vide letter of even No. dated 1.11.2011.
- b. All the recruiting circles may be directed to prepare roster plan of the existing employees in accordance with revised sanctioned strength and calculate category wise vacancies as per existing DoP&T guidelines on roster. The break up of vacancies (i.e. OC/SC/ST) as per Annexure 'A' (which includes vacancies of Non-recruiting circles also) under 50% Internal quota may be sent to GM(Recruitment), BSNLCO directly to e-mail ID at "bsnlrectt@bsnl.co.in", latest by 4th February, 2022.
- c. The eligibility for appearing in the JTO (T) LICE shall be as per JTO RRs of 2014 as endorsed vide this office letter no.5-32/2013-Estt. Dated 14.10.2015.
- d. As per DoPT OM no. 22011/4/2013-Estt(D) Dated 08th May 2017, crucial date for determining the qualifying service (i.e. 5 years) shall be 1st January of the respective vacancy year against which the candidature of the official is being considered.
- e. Cutoff date for reckoning age for 50% internal quota candidates will be 1st January of the vacancy year (i.e. they must be below the age of 55 years as on 1st January of the vacancy year.

- f. Examination will be conducted for 50% quota for vacancy year 2021 i.e for vacancies upto 31.12.2021.
- g. Since, it is a competitive exam, results shall be declared upto the notified vacancies for the particular year i.e 2021.
