Sub: Regarding JTO PH-I Induction training keeping in view of National Training Policy-1996 (O.M. No. 11014/17/93-Trg. Dated 15.04.1996) & NTP-2012 (No. 12021/8/2011-Trg.I dated 19th January, 2012) with keeping in view and considering any further legal litigation

As per BSNL CO letter no BSNLCO-TRG/27(11)/2/2020 dated 22.06.2020 and in compliance of various guidelines/instructions issued by government regulatory/district administration and after examining the current ongoing syllabus for JTO PH-I Training, as per availability of modern live streaming/ online training software and C.O. New Delhi instructions, it has been decided by competent authority to conduct **only theory part of Syllabus i.e. 06 weeks** via online in their hostel rooms/Specified locations/venues with keeping all isolation, advisory/instructions by government regulatory/district administration. **To avoid legal issues & maintain error free seniority, it is decided for conducting 06 weeks theory classes on line by ALTTC, Ghaziabad on prescribed / modified useful course as per present field requirement and when COVID-19 Pandemic situation is normalised, remaining four weeks i.e. (2.5 Hrs. Practical discussion/ GD/ Assignment and 1.5 weeks for Exam/ Practical exams) will be intimated in due course as per C.O. instructions, issued after examining the situations.**

The online JTO phase-I course is going to commence on 06.07.2020. The circle has to ensure venue and attendance of their JTO phase-I trainees and monitoring by ALTTC, Ghaziabad.

It is also mentioned that some areas such as Manipur, J & K or any Circles, where internet problem is there i.e. non feasible area or live platform not available or any other reasons, may be allowed to stay at ALTTC, Ghaziabad for full period (10 weeks) of training, if necessary.
