Sub: - **Loss in pension for the retired Sr.TOAs of Maharashtra circle, due to the wrong interpretation of rules by the CCA, Maharashtra – requesting to take up the issue with the Member (Finance), as per the decision taken in the Formal meeting with the Director (HR) on 28.08.2020- req.**

We wish to bring the following to your kind notice, for favour of necessary follow up action.

As you are aware, in the online formal meeting held with the Director (HR) on 28.08.2020, BSNLEU took up an issue, as mentioned in the subject above. This is the case related to the reduction in pension of the retired Sr.TOAs belonging to Maharashtra circle, due to the wrong interpretation of the rules, by the CCA, Maharashtra. The details of the case are contained in the letter cited under reference (1), a copy of which is enclosed for your kind perusal.
