Sub: - **Modifications sought in the Consolidation of Business Areas – reminding to consider the demands of BSNLEU - reg.**

Ref: - **(1) Our letter no. BSNLEU/503 (CDR) dated 30.09.2020, addressed to the GM (Restg.), BSNL CO.
(2) Our letter no. BSNLEU/604 (DEV) dated 09.11.2020, addressed to the CMD BSNL.**

With reference to the letters cited above, we would like to invite your kind attention to the following, for favour of needful action.

Vide letter cited under reference (1), addressed to the GM (Restg.), BSNL CO., we have requested the Management to reconsider it's decision of bringing Cuddapha SSA under the Ananthapur Business Area, in Andhra Pradesh circle. Instead, we have demanded that, Cuddapha SSA should be brought under the Chittoor Business Area. In that letter, we have explained the reasons for seeking such a modification. We wish to submit that, the modification was sought considering the avoidable problems that will be caused to the employees of Cuddapha SSA, in the name of Consolidation of Business Area.

Vide letter number cited under reference (2), addressed to the CMD BSNL, with copy endorsed to the GM (Restg.), BSNL CO, BSNLEU has demanded that, the Management should give up it's proposal to bring Nagaon SSA under the control of Tezpur Business Area, in Assam circle. Since, both Nagaon SSA and Tezpur SSA are large SSAs, geographically located on the opposite sides of the river Brahmaputra, the employees of Nagaon SSA will face extreme hardship, due to bringing it under the Tezpur Business Area. This proposal will not be in the interest of the Company also. Hence, we have demanded to give up the proposal of bringing Nagaon SSA under Tezpur SSA.

We would like to bring to your kind notice that, so far the Management has not taken any action on the letters cited under reference. Hence, we request you to kindly consider our demands in respect of bringing Cuddapha SSA under the Chittoor Business Area and to drop the proposal of bringing Nagaon SSA under the Tezpur Business Area. We hope that, needful action would be taken in these cases, without further delay.
