With reference to the above, we would like to bring the following to your kind notice.

It is already 17th of June today and still the salary for the month of May, 2021, has not been disbursed to the employees. BSNLEU is religiously writing letters to the Management every month, reminding it of its duty to disburse the salary to the employees on the due date. However, it hurts to note that, the Management continues to ignore the sufferings of the employees on account of non-disbursement of salary on the due date.

We would like to once again remind the Management of the judgements of the various Hon'ble High Courts, as well as that of the Hon'ble Supreme Court that, wherein it has been pronounced in unequivocal terms that, paucity of funds is not an excuse for not disbursing salary to the employees on the due date. This has already been communicated to the Management, vide our earlier letters.

We wish to state that, the Management's continued negligence to disburse salary on the due date, is bound to give room for serious agitations by the employees. The Management alone shall be held responsible for pushing the employees to take recourse to such agitations.

In view of the foregoing, we would like to once again request you to kindly take necessary steps for the disbursement of the salary for the month of May, 2021, without further delay and also to ensure that the salary for the month of June, 2021, is paid on the due date.
