Sub: - **Non-functioning of the BSNL Staff Welfare Board and the BSNL Sports and Cultural Board – requesting for your immediate intervention - req.**

With reference to the letters cited above, we would like to once again draw your kind attention to the subject mentioned above.

It is a matter of deep concern that, the BSNL Staff Welfare Board and the BSNL Sports and Cultural Board are not functioning since March, 2020. As a matter of fact, the last meeting of the sports and cultural board was held on 14-07-2017. The tenure of both these Boards expired in March, 2020 itself. However, the BSNL Management did not take any step to reconstitute both the Boards.

BSNLEU repeatedly took up these issues with the CMD BSNL, vide letters cited under reference. Only after our repeated requests, the BSNL Sports and Cultural Board was reconstituted on 29.11.2021 and the BSNL Staff Welfare Board was reconstituted on 01.12.2021.

It is a matter of regret that, despite having reconstituted the BSNL Staff Welfare Board and the BSNL Sports and Cultural Board, the Management has not taken any action to convene the meetings of both these Boards. We have no hesitation to state that, due to the non-holding of the BSNL Staff Welfare Board, the welfare activities of the BSNL employees are being grossly neglected.

Similarly, interests of the BSNL's sports personnel are not being taken care of, due to the non-holding of the BSNL Sports and Welfare Board. It will not be out of context to state that, the career progression of the BSNL's sports personnel, finalised after discussions held in the Sports and Cultural Board and thereafter approved by the BSNL Board, is being unilaterally violated by the BSNL Management.

Under the above stated circumstances, we earnestly urge upon you to kindly take steps for immediately holding of the BSNL Welfare Board and the BSNL Sports and Cultural Board.
