Sub: - **Non-implementation of the Corporate Office instruction on deduction of monthly union subscription of BSNLEU, at the revised rate - req.**

Ref: - **Corporate Office letter no.BSNL/39-6/SR/2013 dated 10<sup>th</sup> September, 2021.**

Madam,

We wish to draw your kind attention to the following issue, for favour of taking needful and expeditious remedial action.

***The Corporate Office, vide letter cited under reference, has already issued instruction to all the CGMs, for the deduction of monthly union subscription, from the members of BSNLEU, at the revised rate of Rs.70/- per month. It is already 3 years since this letter has been issued.***

However, we are pained to bring to your kind notice that, still monthly union subscription from the members of BSNLEU is being deducted at the old rate of Rs.45/- in the circles of UP(West), Uttarakhand, Chhattisgarh, Bihar, Haryana, J&K, CNTx(South) and CNTx(North).

In this connection, the CHQ of BSNLEU has written letter to the Chief General Managers of all the aforementioned circles, requesting to take prompt action for the deduction of monthly union subscription of BSNLEU at the revised rate of Rs.70/-. We have categorically mentioned names of the districts where the subscription is being still deducted at the old rate. Copies of these letters are enclosed herewith for your kind perusal.

Deduction of monthly union subscription is one of the Trade Union facilities extended to the Recognised Union, by the Management. Hence, it is needless for us to state that, the Management is duty bound to implement it's own order on the subject. Dereliction of responsibility, by the administrations of the aforementioned circles, is highly regrettable.

In view of the foregoing, we earnestly urge upon you to kindly ensure immediate action by the aforementioned circle administrations, for the deduction of monthly union subscription of BSNLEU, at the rate of Rs.70/- per month.
