Sub: - Non-renewal of MoU with the Canara Bank and the Union Bank of India – employees suffering due to non-availability of bank loans – seeking your kind intervention - reg.

We wish to draw your kind attention to the following issue, for favour of necessary action.

Vide letters cited under reference, we have already brought to your kind notice that, the MoUs signed by BSNL with the Canara Bank and the Union Bank of India for the purpose of availing various loans by the employees, have already expired long back. BSNLEU has repeatedly approached you and other important officers in the Corporate Office for the early renewal of the MoUs. However, the MoUs with both the Canara Bank and the Union Bank of India are not yet renewed.

In this connection, we learn that, both Canara Bank and the Union Bank of India are unwilling to renew the MoUs. This may be due to the fact that, in the past, BSNL Management failed to make on time remittance of the EMI dues deducted from the salaries of the employees, to the respective Banks. This was due to the severe financial crisis experienced by BSNL.

If this is the fact, then it will be difficult to get the MoUs with both the Banks renewed, without the intervention from the highest levels, both from BSNL's side and that of the Canara Bank and the Union Bank of India. In view of this, we earnestly urge upon you to kindly take up this issue with the Heads of the Canara Bank and the Union Bank of India, so that the MoUs could be renewed. We fondly hope that, you would do the needful to put an end to the sufferings of the employees.
