Sub: - **Issuing of Presidential Order to Shri Jeet Ram Thakur, Junior Engineer, Bilaspur, on the analogy of the DoP&PW letter no.57/05/2021-P&PW(B) dated 03rd March, 2023 – req.**

Ref: - **DoT letter no.36-03/2019-Pen(T) dated 17.04.2023.**

Sir,

With reference to the letter cited above, we wish to bring the following to your kind notice, for favour of necessary action.

The Department of Pension and Pensioners Welfare, vide it's letter no.57/05/2021-P&PW(B) dated 03rd March, 2023, has given a onetime option to such of the Central Government employees who were recruited against vacancies occurred before 01.01.2004, to be covered under the CCS Pension Rule-1972 (now 2021). The DoT, vide it's letter cited under reference, has endorsed this letter of the DoP&PW.

In BSNL, there are employees who were recruited against the posts / vacancies advertised / notified for recruitment, prior to the formation of BSNL. The actual appointments of these employees have been made after formation of BSNL. Hence, no Presidential Order is issued to these employees and they are deprived of their pension as per CCS Pension Rules-1972 (now 2021).

Some employees who belong to the above mentioned category are approaching BSNLEU, which is the Main Recognised Trade Union in BSNL, for taking up their case with the DoT, so that Presidential Order can be issued to them. One such employee is Shri Jeet Ram Thakur, Junior Engineer, Bilaspur, Himachal Pradesh circle, having HRMS No.200100541.

Shri Jeet Ram Thakur was recruited as Lorry Driver, against the vacancy advertised by the CGMT, Haryana circle, vide letter no.E&R/R-301/LD/DR-99/40 dated 19.01.2000. Obviously, this advertisement has been made before the formation of BSNL. However, after the completion of all formalities, Shri Jeet Ram Thakur has joined duty as Lorry Driver only on 23.04.2001. Since Shri Jeet Ram Thakur has been recruited against the vacancy which has been notified before the formation of BSNL, the official is requesting for the issuing of the Presidential Order on the analogy of the DoP&PW letter no.57/05/2021-P&PW(B) dated 03rd March, 2023, endorsed by the DoT, vide it's letter no. 36-03/2019-Pen(T) dated 17.04.2023.

We earnestly urge upon you to kindly look into this case and to take the needful action for the issuing of Presidential Order to Shri Jeet Ram Thakur who is presently working as Junior Engineer, at Bilaspur, in Himachal Pradesh circle.
