Sub: - **Request transfers of JEs under Rule-8 – Non-implementation of Corporate Office instruction by West Bengal circle – requesting for your kind intervention – req.**

Sir,

We wish to draw your kind attention to the subject mentioned above, for favour of necessary action.

The Corporate Office has issued clear-cut direction to the circles, with regards to the request transfer of JEs, under Rule-8. As per the direction of the Corporate Office, JEs from surplus circles can be transferred to deficient circles. This is being followed by most of the circles.

However, it has been brought to our notice that, West Bengal, which is a surplus circle, is not processing the requests of JEs for transfer under Rule-8, to the deficient circles. For example, from West Bengal circle, JEs have applied for transfer to deficient the circles of Kolkata and Karnataka. These request transfers should be considered as per the direction of the Corporate Office. However, West Bengal circle is not processing these cases for implementing the transfers.

We are enclosing herewith a list of 9 officials, who have applied for transfer under Rule-8 from West Bengal to other deficient circles. We request you to kindly intervene in this matter, so that the request transfers under Rule-8 from West Bengal circle are implemented as per the direction of the Corporate Office.
