Sub: - **Requesting to declare the Punjab circle JTO LICE results for the vacancy year 2014-15, by carrying forward the unfilled JTO posts of the vacancy year 2013-14 - req.**

We wish to bring the following to your kind notice, for favour of necessary action.

The results of the JTO LICE conducted for the vacancy year 2014-15 in Punjab circle, are not declared so far due to the pendency of court cases. BSNLEU has been consistently pressing on the Management for the early declaration of the JTO LICE results, by finding a solution to the litigations. It is under this circumstance that, the OA No.60/742/2018 filed by Ms.Parmindar Kaur, which has been going on in the Hon'ble CAT, Chandigarh Bench, has been dismissed as withdrawn on 11-10-2023.

Thus, whatever legal deadlock that has hindered the declaration of the JTO LICE results for the vacancy year 2014-15, has been removed now. As such, the Punjab circle administration has to take necessary steps for the immediate declaration of the JTO LICE results for the vacancy year 2014-15.

In this connection, we would like to bring to your kind notice that, in Punjab circle, 18 posts belonging to the OC category, 58 posts belonging to the SC category and 97 posts belonging to the ST category have remained unfilled in the JTO LICE conducted for the vacancy year 2013-14. As has been done in all other circles of BSNL, these unfilled posts of the vacancy year 2013-14 should have been carried forward to the JTO LICE conducted for the vacancy year 2014-15.

However, it is a matter of deep regret that, the Punjab circle administration conducted the JTO LICE for the vacancy year 2014-15, without carrying forward the unfilled posts of the vacancy year 2013-14. As a result of this lapse on the part of the Punjab circle administration, 18 OC candidates and 58 SC candidates of Punjab circle have lost their opportunities of becoming JTO. This is a great injustice done to the Punjab circle candidates. We strongly feel that even now the Management can undo this injustice.

In view of the foregoing, we fervently appeal to you to kindly consider the following:-

- (1)** All legal obstacles that hindered the declaration of the JTO LICE results for the vacancy year 2014-15 have been removed now and the BSNL Management is at it's liberty to declare the results.
- (2)** At this juncture, we earnestly urge upon the Management to kindly do the needful for the declaration of the 2014-15 JTO LICE results, by carrying forward the 18 OC JTO posts and the 58 SC JTO posts that were not filled in the JTO LICE held for the vacancy year 2013-14. (There are no ST candidates in Punjab circle now).

(3)The BSNL Management is completely at it's liberty to declare the results of the year 2014-15, by carrying forward the unfilled posts of the vacancy year 2013-14.

We request you to kindly consider our request and to pave the way for the promotion of 18 more OC candidates and 58 more SC candidates as JTOs.
