Sir,

We wish to bring the following to your kind notice for favour of your immediate intervention and necessary action.

The JTO LICE was held on 08.09.2024, the results of which have been declared a few days back. After declaration of the results, some candidates have approached our Union with their grievance. These candidates have gone on Rule-8 transfer some time before the JTO LICE is held. After their joining in the new circles, necessary updating should have been made in the SAP ERP, with regards to their "parent circle status". However, it seems that certain circle administrations have failed in making this updating.

As a result of the aforementioned discrepancy, some candidates are facing problems now. Since their "parent circle status" has not been updated in the SAP ERP, their names did not figure in the merit list, even though they have scored more marks than the selected candidates. In this connection, Chhattisgarh circle and Odisha circle have sent letters to the AGM (Rectt.), BSNL Corporate Office, copies of which are enclosed herewith.

Since, the "parent circle status" of the candidates has now been updated in the SAP ERP, we request you to kindly undertake necessary review of the JTO LICE results and render justice to the deserving candidates.


