## Sub: - Special JTO LICE - non-filling up of the notified posts in Kerala circle - reg.

We wish to bring the following to your kind notice for favour of necessary action.

It has been brought to our notice that, the notified posts for the Special JTO LICE, held on 18.12.2022, were not filled up in Kerala circle, even though eligible candidates are there. As per the notification, the number of posts available in Kerala circle were OC - 59; SC - 11 and ST - 6.

However, among these posts, only 49 OC posts, 12 SC posts and 6 ST posts were filled up respectively. The remaining OC posts are not filled up. One candidate, by name Shri Rahul Sharma (roll no.600004), who appeared in the Special JTO LICE for Kerala circle, has secured 86 marks. However, he has not been selected.

Even if 4% posts are earmarked for the PWD candidates, still 59 posts are available for the OC candidates, out of which only 49 posts are filled up.

In view of the foregoing, we request you to kindly get the matter examined and to take necessary steps for filling up the remaining unfilled posts, with the candidates who have secured the requisite marks. We are enclosing here with a copy of the representation submitted by Shri Rahul Sharma, roll no.600004, for favour of your kind consideration.

Subject: - Regarding non filling of notified seats in Kerala Circle in Special JTO LICE held on 08.12.2022.

As per the subject written above, I Rahul Sharma, JE, IT, ALTTC, Ghaziabad, want to bring to your kind notice that few seats of Special JTO LICE of Kerala circle remained unfilled as per the merit list declared by BSNL, CO office, New Delhi. I Rahul Sharma (Roll No. 600004), secured 85.75 marks and had opted one of my choices as Kerala circle at the time of registration, but due to partial/incomplete declaration of result (Merit list) in Kerala Circle has deprived me to fall in the merit list of Kerala Circle.

The result of the Special JTO LICE was put on hold due to PWD reservation case arose by one of candidates of Haryana circle, but later after stay had been vacated by court, giving direction to reserve 4% vacancy unfilled for PWD reservation.

BSNL management followed this court direction and soon declared the Special JTO LICE merit list but the vacancy calculation as per the court order remains ambiguous, and after many calculations and exercises it came in notice that few OC seats of Kerala circle is still vacant and result has not been declared by management on those seats.

The number of seats in Kerala was 59 for OC, 11 for SC and 6 for ST but merit list shows only 49 seats filled up by candidates of OC and 12 and 6 for SC and ST respectively. 1 seat of SC is extra declared.

The Calculation of these seats are taken from the notification issued by management on office website of BSNL (internalexam.bsnl.co.in)

For example (Maharashtra)

OC-60, SC-12, ST-06, Total-78

All seats are filled and no seats remained vacant in case of Maharashtra and all other remaining circles but in case of Kerala circle, all notified seats are not filled and remained vacant out of the mentioned vacancies notified in notification.

If let us suppose 4% reservation of PWD candidates are applied in Kerala circle then calculation will be OC- 59 SC-11 ST-06 Total =76

4% of 76 is = 3

Then vacancy will be OC= 59-3 = 56

But result declared only for 49 OC vacancies, 7 seats are still remained undeclared. Also 1 extra seat of SC is added, but the notified seats for SC were 11 but result declared for 12 seats.

In this context, I request upon you to kindly intervene and correct the merit list of Special JTO LICE as the problem is directly linked with the career and future growth of the employee.
