Reference:- Letter No. BSNLCO-A/15(14)/2/2022-ESTAB dated 01.02.2022.

I am directed to refer to aforesaid letter under reference and to convey the approval of the competent authority to conduct aforesaid LICE. The Model Exam Notification for LICE to the cadre of Telecom Technician (TT) is enclosed and same has to be notified by above mentioned (15) circles accordingly.

- 2. The examination shall follow the Recruitment Rules of Telecom Technician 2012 issued vide letter no. 250-3/2012-Pers.III dated 19.09.2012. The said LICE for Telecom Technician (TT) shall be conducted in accordance with the scheme and syllabus prescribed vide office letter no. 250-74/2001-pers.III (Pt.) dated 18.10.2011.
- 3. The vacancy shall be calculated strictly OA wise in Circles as on 31.12.2020 for VY 2020 and as on 31.12.2021 for VY 2021. The crucial date for reckoning the eligibility of candidate for appearing in the said LICE shall be 1st, January, 2020 for VY 2020 and 1st January, 2021 for VY 2021. Number of LICE vacancies for each of these vacancy years for each of these 15 Circles has already been intimated vide Estt. Branch letter dated 01.02.2022 referred above. The circles shall distribute these vacancies OA wise and category wise (OC, SC, ST and PwBD) and incorporate the same in the notification to be issued by them in accordance with the model notification annexed. It may be noted that total LICE vacancies for a Circle for each of the VY 2020 and 2021 shall not exceed the number conveyed vide Estt Branch letter dated 01.02.2022 referred above (Enclosed).
- 4. It may also be noted that the LICE of Telecom Technician (TT) may be held only for those OAs where there is a clear vacancy. The vacancies of the Non-Recruiting Circles may also to be taken into account while notifying the vacancies of the particular OA of the Circle.
- 5. The Circles are requested to intimate vacancies, OA wise to Establishment Section of Corporate office (being cadre controlling authority) with a copy to Recruitment Branch, BSNL CO categorically so that the same would be available only in the drop down menu in the registration portal for such candidates who are eligible to apply against that vacancies of that particular OA.
 - i. In case of any doubt for calculating vacancies position in an OA of the circle, cadre controlling authority i.e Establishment Section, BSNL CO may be consulted.
 - ii. The Circles shall also provide a copy of the notification issued by them to Establishment Section, BSNL CO and to Recruitment Branch, BSNL CO so that the vacancy position in respect of a particular OA would be available in the drop down menu in the Registration portal for such candidates only who are eligible to apply against those vacancies of that particular OA.

- i. The LICE shall be held in CBT online mode. All the questions will be of multiple choice Question (MCQ) type. Each question contains four options and the candidate has to select only one correct answer. There would be negative marking and for each wrong answer 25% of the mark of that question would be deducted.
- ii. It is reiterated that LICE will be held in concerned 15 Telecom circles strictly, for such OAs where vacancies exist, in centralised manner by BSNL Corporate office on the fixed date and time.
- iii. It is informed that checking the eligibility condition of the aspiring candidates will be the sole responsibility of the circles by going through their service book of all probable candidates for the said LICE. Therefore, Circles should ensure that service particulars of candidates are up-to-date in all respects to avoid any kind of pre/post exam discrepancies. Further, circles should ensure that only eligible candidates appear in the examination and send the details of the eligible candidates to Recruitment section well in advance for issue of their admit card by the Exam Agency.
- iv. On completion of Exam, the list of qualified candidates of each circle will be shared by Rectt. Branch with the circles which will declare the merit wise result for the respective circles as per the notified vacancies (OA-wise/category-wise).
- 7. All circles will arrange training at OA level to familiarize the aspiring candidates for appearing in online CBT based LICE.
- 8. All the above mentioned circles are requested to issue notification along with vacancies (with break-up of category OA wise) within 15 days of receipt of this letter with a copy to Establishment Section BSNL CO for vetting of vacancies and to Recruitment Section, BSNL CO for creating drop down.
- 9. An examination conducting team with suitable nos. of members shall be constituted, wherein an Executive/Officer not below the rank of GM (preferably from HR/Admin sections) would be the Examination Coordinator.
- 10. The Examination Coordinator then shall nominate the Examination Superintendent (ES) not below the rank of <u>DGM or equivalent</u>. The Examination Coordinator Shall also depute Examination Observer (EO) at every exam centres irrespective of numbers of candidates. The Examination Observer (EO) should not be below the rank of <u>AGM/DE/EE</u> or equivalent. The Examination Observer (EO) would submit the report to the Examination Coordinator. The duties and responsibilities of Examination Co-ordinator (EC), Examination Superintendent (ES) and Examination Observer (EO) will be sent separately.

- I. The number of vacancies mentioned above is tentative and subject to change. Reservation will be effective as per guidelines /policy/court orders by Govt. of India, if any.
- II. Since the Jarnail Singh batch of cases is pending in the Hon'ble Supreme court of India, any promotion order issued shall be subject to the outcome of further orders that may be passed by the Supreme court in the said case.
- III. The LICE for promotion to Telecom Technician(TT) shall be conducted as per provisions laid in the Recruitment Rules (RR) of Telecom Technician(TT) circulated vide BSNL Corporate Office Letter No. 250-3/2012-PERS-III dated 19.09.2012 (ANNEXURE-B).

- VII. The Circles are requested to intimate vacancies, OA wise through Establishment Section of Corporate office (being cadre controlling authority) with a copy to Recruitment Branch, BSNL CO categorically so that the same would be available only in the drop down menu in the registration portal for such candidates who are eligible to apply against that vacancies of that particular OA.

- 3. It is further informed that in RR of Telecom Technician (TT) 2012 issued vide Ltr. No. 250-3/2012-PERS-III dated 19.09.2012, the date of reckoning of eligibility for Limited Internal competitive examination will be 1st July of the Recruitment year. As per DoP&T instructions endorsed by Establishment branch vide its letter no. BSNL CO-A/15(14)/2/2022-

ESTAB dated 01.02.2022 (Annexure D), crucial date for determining the qualifying service shall be 1st January of the respective vacancy vear instead of 1st July of the Recruitment vear.

- **4.** . Subject to para 3 above, the eligibility for appearing in the above mentioned Limited Internal Competitive Examination shall be as per existing Recruitment Rules of Telecom Technician (TT) issued by cadre controlling authority of BSNL CO vide their letter no. 250-3/2012-PERS-III dated 19.09.2012. In case of any doubt with regard to eligibility, schemes and syllabus of the examination, the circles may take up the matter suitably with the cadre controlling authority i.e Establishment Branch of the BSNL CO for necessary clarification.

- a. All the questions will be of Multiple choice Question (MCQ) type. Each question contains four options and the candidate has to select only one correct answer. There would be negative marking and for each wrong answer 25% of the mark of that question would be deducted.
- b. Minimum qualifying marks prescribed is as under:-

Note: There shall be no further relaxation of marks or any other parameter under any circumstance owing to maintenance of efficiency of administration.

- **6.** The LICE will be held at Circle Head Quarters indicated at (Annexure-E).
- 7. The OA/BA Heads are requested to ensure updating of service particulars from the service book of all probable candidates for the said LICE for timely e-verification of eligibility through ERP.
- 8. The employees, who are eligible in accordance with the eligibility conditions as referred in the Recruitment Rules and who desire to appear in the examination should submit the application through online mode. Applications will be considered through the online registration process only. Therefore, candidates are advised to visit BSNL Intranet site (www.intranet.bsnl.co.in) for any updates regarding the said LICE. All candidates applying for LICE for Telecom Technician(TT) are required to read all the instructions provided on website www.internalexam.bsnl.co.in before filling the online application form. Candidates must have valid E-mail ID and mobile number at the time of on-line registration. After submitting the application on-line, the applicant shall retain a hard & soft copy of the application form for record. Data are also required to be verified in SAP/ ERP.
- 9. The prescribed examination fee shall be Rs.500/-(Rupees Five Hundred only) for the OC candidates, and Rs. 250/- (Rupees Two Hundred Fifty only) for the SC/ST candidates. The fees shall be paid through on-line mode i.e. Internet Banking, Credit Card, Debit Card etc. Fee once paid for the said LICE shall neither be refunded under any circumstances nor can be held in reserve for any other examination or selection even if the said exam is not conducted due to any administrative reasons. Candidates are requested to ensure their eligibility for the said LICE before applying for the same.
- **10.** Candidates are advised to complete their online registration process well before the last date to avoid last day rush/unforeseen circumstances. Online registration process will not be allowed after the last date and all incomplete registrations will be rejected.
- 11. The applicants would be admitted to the examination on the basis of data/information furnished by them during online registration. Candidates are, therefore, once again advised to ensure that they fulfill all eligibility conditions before applying. The applicant must also ensure regarding his parent circle / category while filling the same in online application. In case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfill any of the eligibility conditions, the candidature of such applicants shall be cancelled even if the candidate qualifies in the LICE and no

correspondence in this regard shall be entertained. Issuance of an admit card/Hall Ticket for the examination will NOT confer candidates any right for promotion/appointment etc. The promotion/appointment will be solely subject to fulfillment of all eligibility conditions & availability of vacancies in the concerned OAs provided by concerned authorities.

- **12.** BSNL shall display/provide the questions & provisional answer key on the **www.internalexam.bsnl.co.in**, soon after the Exam, for a stipulated period, wherein candidates shall be provided with a suitable format to submit their online grievances/queries on question/answer options only. On the basis of grievance received from candidates, if any, the final answer key & merit list shall be deployed as per prevailing guidelines.
- 13. Issuance of candidate response sheet, score card etc. for the said LICE shall NOT confer candidate any right for promotion/appointment etc. The promotion/appointment will be solely subject to fulfillment of all eligibility conditions and magnitude of qualified marks secured vis-àvis availability of vacancies.
- **14.** Nothing other than specified in the Admit card be permitted to be taken inside the examination premises by the candidates. Violation of the instructions at any stage will make the candidate liable for disqualification of the candidature without assigning any reason thereof.
- **15.** All concerned BA heads are requested to arrange for the pre exam training to aspiring SC/ST/Minority candidates for aforesaid LICE, as per admissible rules.
- **16.** Promotion on the basis of result of this examination will be subject to the outcome of court cases pending in different courts on the issue related to reservation and also mentioned in para 2 (ii) above and the DoP&T instructions issued from time to time in this regard.
- 17.
