Sub: - **Whimsical transfer implemented in CNTX(North) circle – requesting for your kind intervention – req.**

We wish to bring the following to your kind notice for favour of necessary action.

It has been brought to our notice by the Circle Union of BSNLEU, CNTX(North) that, Shri S.C. Ramola, Assistant Circle Secretary, BSNLEU, has been transferred. Shri S.C. Ramola is the Assistant Circle Secretary of BSNLEU and hence he is covered by the Corporate Office instructions on Immunity from Transfers.

However, when this issue is discussed with the circle administration of CNTX(North), it is replied that, the official has been shifted only from Eastern Court to Karol Bagh and hence cannot be termed as a transfer. It is being complained by the Circle Union of BSNLEU, CNTX(North) that, the Assistant Circle Secretary of BSNLEU has been disturbed in a "Pick and Choose" method. It is also being complained that, the CNTX(North) administration is not adopting any yardstick in the transfer of Shri S.C. Ramola, Assistant Circle Secretary, BSNLEU.

We would like to submit that transferring officials either from one station to another station, or within the station, without adopting any yardstick cannot be permitted. The administration has to follow some yardstick in transferring officials within the station or out of the station. Further, a big city like Delhi, shifting the officials from one place to another place causes great deal of inconvenience and difficulty to the officials. Hence, the claim of the CNTX(North) administration, that Shri S.C. Ramola has been shifted only within Delhi, cannot be accepted. This argument does not confer the right on the CNTX(North) administration to disturb officials without any criteria and on pick and choose method.

In view of the forgoing, we would like to request you to kindly look into the matter and to ensure that the CNTX(North) Circle administration is not permitted to implement whimsical transfers. We request you to kindly do the needful at the earliest.
