- Sub: <u>Transfer of JEs from the surplus circles to the deficient circles non-compliance of the Corporate Office instructions</u> <u>by the NE-1 and NE-2 circles reg.</u>

With reference to the letter cited (1) above, we wish to bring the following to your kind notice, for favour of information and necessary action.

BSNLEU is continuously pressing on the Management that, the requests of all the DR JEs who have completed five years of service and who have applied for transfer under Rule-8, should be considered expeditiously.

The Corporate Office has issued a letter, directing that the requests of the DR JEs who have applied for transfer under Rule 8, from surplus circles to the deficient circles, should be considered. Already, we have brought to your kind notice that, this instruction of the Corporate Office is being thrown to the winds by the NE-1 circle. Vide letter cited under reference (2), BSNLEU has already drawn your kind attention to this matter.

Further, we wish to bring to your kind notice that, the instruction of the Corporate Office for transferring the DR JEs from the surplus circles to the deficient circles, is not being implemented by the NE- 2 circle administration also.

The sanctioned strength of JEs for NE-2 circle is 32. Whereas, 83 JEs are presently working in that circle. Thus, NE-2 circle clearly falls under the category of the surplus circle.

However, the requests of the DRJEs for transfer under Rule 8, from NE-2 circle to other deficient circles, are not being considered. We are receiving complaints that, the transfer applications of the DR JEs are not even being forwarded to the Circle Office, by the district administrations of NE-2 circle. This is nothing but a blatant violation of the instruction of the Corporate Office.

In this connection, we would like to further draw your attention to the case of Arunachal Pradesh district. The sanctioned strength of JE's of Arunachal Pradesh district is only 12. Whereas, 35 JEs are presently working in this district. Still, the requests for transfer under Rule 8, by the DR JEs, are being straight away rejected by the district administration, without even forwarding the same to the NE-2 Circle Office.

We are deeply concerned to bring to your kind notice that, both the NE-1 and NE-2 circles are completely violating the instructions of the Corporate Office. Further, the district administrations of both the NE-1 and NE-2 circles are behaving in a high-handed manner and are not even forwarding the transfer applications of the DR JEs to their respective Circle Office. This state of affairs prevailing in NE-1 and NE-2 circles is reprehensible and warrants your immediate intervention, for safeguarding the interests of the DR JEs of NE-1 and NE-2 circles.

In view of the foregoing, we request you to kindly make immediate intervention on this issue and to give strict instruction to the circle administrations of both NE-1 and NE-2, to abide by the instructions contained in the Corporate Office letter, with regards to the implementation of Rule 8 transfers of the DR JEs.
