Sub: - **Requesting to relax the condition imposed for availing "Two Hours Daily-Off" for Practice - reg.**

Ref: - **Corporate office letter no.27-1/2022-BSNL(S) dated 20th December, 2022.**

Sir,

With reference to the letter cited above, we wish to bring the following to your kind notice for favour of necessary action.

The BSNL Corporate Office has issued "The Revised and Updated Compendium on Sports in BSNL", vide letter cited under reference. This Compendium has made modification to the eligibility for "two hours of Daily-Off for practice". In accordance with this compendium, sports persons will be eligible for "two hours of Daily-Off for practice" throughout the year, provided they have given one medal-winning performance in any International, National or National level event during the preceding 4 calendar years.

We are in general agreement with the condition stipulated as above. However, we wish to bring to your kind notice that, this condition has created difficulty to many sports persons in availing two hours Daily-Off for practice. This is because, due to Covid Pandemic and consequent lock-down, International, National or National level Sports Meets were not held in the years 2020 and 2021. Thereafter, Sports Meets were held in the years 2022 and 2023. However, in 2022 and 2023, all the sports events did not take place. Only some selected sports events took place in the years 2022 and 2023. For example, National / National level Basketball event has taken place only in 2024, after 2018.

Under such circumstances, the condition stipulated that, only the sports persons who had given medal-winning performance in the preceding 4 four calendar years can avail "two hours Daily-Off for practice", has created difficulties to many sports persons. When no Sports Meets have taken place in 2020 and 2021 and also when only few sports events are included in 2022 and 2023, imposition of the aforementioned condition, has deprived many sports persons of their eligibility for two hours Daily-Off for practice.

In view of the foregoing, we request you to kindly relax the condition imposed for availing two hours Daily-Off for practice for two years, i.e., for the years 2025 and 2026, so that all the sportspersons get their two hours Daily-Off for practice. This will really help our sportspersons to prepare themselves for the National/ National Level Meets. We request you to kindly consider our request and help the sportspersons.
