Sub: - **Violation of jurisdiction by Shri Vidyanand, GM, Gorakhpur – requesting to immediately make kind intervention - req.**

We wish to draw your kind attention to the following, for favour of necessary action.

The case relates to Shri Vidyanand, GM, Gorakhpur, who is violating his jurisdiction and is taking action to harass an employee working in Ghazipur OA, coming under Varanasi BA. It is reported that, Shri Vidyanand, GM, Gorakhpur, has received a letter carrying allegations about his own corrupt practices. It is alleged that, the letter is written by Shri Rakesh Kumar Maurya, District Secretary, BSNLEU, Ghazipur OA.

Even though, Ghazipur OA, does not come under the jurisdiction of Gorakhpur BA, Shri Vidyanand, GM, Grakhpur, has constituted a Committee to enquire into the involvement of Shri Rakesh Kumar Maurya, District Secretary, BSNLEU, Ghazipur OA, in sending the letter carrying allegations of his own corrupt practices. He has appointed Shri Neeraj Kumar Singh, AGM (NWP), Gorakhpur as the enquiry officer. Shri Neeraj Kumar Singh, AGM(NWP), Gorakhpur, has called for explanation from Shri Rakesh Kumar Mauraya, District Secretary, BSNLEU, Ghazipur OA, asking him to prove the irregularities and corrupt practices mentioned in the letter, alleged to have been written by Shri Rakesh Kumar Maurya, District Secretary, BSNLEU, Ghazipur OA.

This is a clear case of violation of jurisdiction by Shri Vidyanand, GM, Gorakhpur. He has no business to constitute an enquiry committee against the omissions and commissions of an employee working in Varanasi BA. As per the procedure, Shri Vidyanand, GM, Gorakhpur, should have taken up this matter with the CGM, UP (East) circle, for necessary action.

Even then, Shri Rakesh Kumar Maurya, District Secretary, BSNLEU, Ghazipur OA, has given his explanation and has denied that he has written any such letter to Shri Vidyanand, GM, Gorakhpur, levelling allegations of his own corrupt practices. Further, he has also stated that, someone has done mischief by pasting his scanned signature on a forged letter. Further, Shri Rakesh Kumar Maurya, District Secretary, BSNLEU, Ghazipur OA, has also made a complaint to the cyber crime stating that someone has misused his scanned signature.

The actions, of Shri Vidyanand, GM, Gorakhpur, as described above, are totally anarchic and hence unacceptable. If other BA Heads in BSNL start behaving like Shri Vidyanand, GM, Gorakhpur, it will only bring chaos in the Organisation. In view of this, we earnestly urge upon you to kindly look into this matter emergently and to restrain the anarchic and chaotic behaviour of Shri Vidyanand, GM, Gorakhpur.
