Sub: - **Arbitrary decision of the BSNL Management to cancel the JTO LICEs held in Punjab circle for the VYs 2015-16, 2016-17 and 2017-18 held on 11.12.2016, 20.01.2019 and 26.05.2019 respectively – requesting to review the decision and declare the results – req.**

Ref: - **BSNL letter no.BSNLCO-A/16(17)/5/2023-ESTAB dated 20.02.2024.**

The results of the JTO LICEs conducted in Punjab circle for the Vacancy Years of 2014-15, 2015-16, 2016-17 and 2017-18 were not declared due to the pendency of court case. Consequent to the withdrawal of the court case on 11.10.2023, the roadblocks created for the declaration of the results of the JTO LICEs were cleared. Thereafter, result of the JTO LICE conducted for the vacancy year 2014-15 was declared and the successful candidates have been sent for training.

However, the Corporate office vide letter number cited under reference has cancelled the JTO LICEs conducted for the vacancy years 2015-16, 2016-17 and 2017-18. The reason given by the Corporate Office is that, there is excess manpower in JTO(T) cadre in Punjab circle.

This decision of the BSNL Management is arbitrary and high-handed. In the same exams conducted in other circles, results are declared and successful candidates have already become JTOs. How is it fair to cancel the JTO LICEs conducted in Punjab circle alone and that too after 8 long years. When the JTO LICE results of all other circles, including circles where JTOs are in surplus, are already declared, why the JTO LICEs of Punjab circle alone are cancelled? The Management is answerable to this question.

***BSNLEU has called on it's circle and district unions to organise protest demonstrations on 06.03.2024, against the arbitrary and high-handed decision of the BSNL Management to cancel the JTO LICEs conducted in Punjab circle for the vacancy years 2015-16, 2016-17 and 2017-18.***

In view of the foregoing, we earnestly urge upon you to kindly revisit the decision taken to cancel the JTO LICEs conducted in Punjab circle for the vacancy years 2015-16, 2016-17 and 2017-18. We request you to kindly declare the results of the aforementioned JTO LICEs without delay.
