Sub: - <u>Payment of the arrears of the IDA increase w.e.f. 01.10.2020, 01.01.2021 and 01.04.2021 for the Non-Executives of BSNL- reg.</u>

We would like to draw your kind attention to our earlier letter, cited under reference (3), for the subject mentioned above, for favour of necessary action.

You are aware that, BSNLEU filed a writ petition in the Hon'ble High Court of Kerala, with the prayer to declare that the DPE's letter no.W-02/0039/2017-DPE(WC)-GL-XVI/20 dated 19.11.2020 to freeze the IDA, was not applicable to the Non-Executives of BSNL. Accordingly, the Hon'ble Kerala High Court, vide it's order cited under reference (1), has held that, the IDA freezing is not applicable to the Non-Executives.

The DPE, vide it's letter cited under reference (2) has notified the details of the IDA increase that has become due w.e.f. 01.10.2020, 01.01.2021 and 01.04.2021.

In the letter cited under reference (3), we have requested the BSNL Management that, the arrears of the notified IDA should be paid to the Non-Executives of BSNL without further delay. Since, no order has been issued till date, we earnestly urge upon you once again to ensure that, the arrears of the IDA, w.e.f. 01.10.2020, is paid to the Non-Executives immediately.
