This issue is again discussed with the Establishment Branch of the Corporate Office yesterday. We received the reply that, the case is still lying pending since the CGM Office, Bihar circle, has not carried out the following directions issued by the Corporate Office.

- (1) All the above mentioned officials have been appointed as temporary / provisional ATTs. Their Presidential Orders cannot be issued unless order is issued by the Bihar circle administration to appoint all these 7 ATTs on regular basis.
- (2) Further, the Bihar CGM Office has also still not furnished certain details, required by the Corporate Office.

In view of the foregoing, I request you to kindly take up the issue with the Bihar circle administration and demand that, regular ATT order should be issued to all the 7 officials, with intimation to the Corporate Office. Besides, other details called for by the Corporate Office should also be sent to the Corporate Office without further delay.
