Sub: - **Commencement of the "BSNL Employees Health Insurance Policy, 2021" – reg.**

We wish to bring the following to your kind notice for favour of necessary action.

Based on the demand put forth by BSNLEU, the BSNL Management has taken steps to implement a Medical Insurance Policy for the employees. Vide letter cited under reference, the "BSNL Employees Health Insurance Policy, 2021" has already been notified by the BSNL Management.

According to the terms and conditions of this Health Insurance Policy, this insurance policy is to become operational w.e.f 01-09-2021. If the insurance policy is to become operational w.e.f. 01.09.2021, then the premium amount is to be remitted to the insurance company, by the employees, prior to this date.

In view of this, we request that, the salary for the month of August, 2021, may please be paid on 31st August, 2021 itself, so that the premium amount could be deducted from the August salary and could be remitted to the Insurance Company to ensure the operationalisation of the health insurance policy w.e.f. 01.09.2021.

If this cannot be done, alternatively, the premium amount should be remitted by the BSNL Management, to the Insurance Company in advance, to ensure the operationalisation of the Health Insurance Policy w.e.f. 01.09.2021.

We request you to kindly look into this issue and to do the needful, with the view to enable the Health Insurance Policy to become operational from 01.09.2021 without any hitch.
