With reference to the letters cited above and in continuation of the discussion that we had with you today, we wish to bring the following to your kind notice, for favour of necessary action.

It was decided in the 26th meeting of the National Council held on 27th February, 2012 that, one more Special JTO LICE would be conducted for the draftsman cadre of Civil / Electrical / Telecom wings. Even though, BSNLEU is continuously taking up this issue with the Management, the decision of the National Council is not yet implemented. It is understood that, the CGM (BW), Corporate Office and the CGM (EW), Corporate Office have not sent their proposals to the Establishment Branch, for holding this Special JTO LICE.

In view of the foregoing, we request you to kindly do the needful for holding the Special JTO LICE, as per the decision taken in the 26th meeting of the National Council, at the earliest. Copies of the letter cited under reference are enclosed for your kind perusal.

Sub: - Non-implementation of the decision taken in the National Council- requesting for your kind intervention-reg.

We wish to draw your kind attention to the non-fulfilment of the assurance given on the floor of the National Council. We are bringing this case to your kind notice, with the fond hope that needful action will be taken at least at this stage.

In the 26th meeting of the National Council, held on 27th February, 2012, BSNLEU raised the demand that, one more chance should be given to the Draughtsmen Civil/Electrical /Telecom, to appear in the JTO (Civil) /JTO (Electrical) exam.

This demand was raised on the ground that, the Draughtsmen (Civil/Electrical /Telecom), who possessed the requisite educational qualification, were allowed to appear in the JTO (Civil / Electrical) exam in 2008, against the 50% quota. However some Draughtsmen, possessing the requisite qualification, could not appear in this exam, since they had not completed 10 years of service at that time. In reply to the issue raised by the BSNLEU, the official side informed that, the issue was already under examination.


Once again, this issue was raised in the 28th meeting of the National Council, held on 30th January, 2013. In this meeting, the Official Side replied that, the case was under active consideration for seeking the approval of the competent authority. However no action has been taken and the issue has been kept in the cold storage. Despite many representations reminders given by BSNLEU, only some wishy- washy replies are given, but the assurance given on the floor of the National Council has not been implemented by the Management.

It may not be out of context to mention here that, the Corporate Office, vide file no. 2-10/2008-TE-I dated 21/07/2001, has already declared the Draughtsman cadre as a "wasting cadre". Accordingly, the Draughtsman posts shall stand abolished once the officials retire, resign or get promoted. It is also worth mentioning that, the designation of the Draughtsman cadre has already been changed as Junior Engineer.

Under these circumstances, we once again request you to kindly take the necessary steps for the implementation of the decision taken on the floor of the National Council.
