Sub: - Inordinate delay in holding the JE LICE - reg.

With reference to the above, we wish to bring the following to your kind notice, for favour of necessary action.

The holding of JE LICE for the Recruitment Years 2017-18 and 2018-19 are getting inordinately delayed. BSNLEU, vide it's letters cited under reference, has already written to the Management, requesting to hold the exam without further delay. However, we are extremely sorry to state that, the Management has not taken any action in this regard so far.

The Recruitment Section of the BSNL Corporate Office initially announced the date for JE LICE under 50% quota for the year 2017-18 on 07.04.2019. However, the Management tried to hold the exam 'on-line'. BSNLEU objected to the conducting of JE LICE as an 'on-line' exam. The matter was discussed in the 37th meeting of the National Council held on 20.11.2018. After detailed discussion, the Chairman of the National Council agreed to our demand that all "Non-Executive to Non-Executive" exams should be conducted as 'off-line' exams. Based on this decision, the Director (HR) instructed the Recruitment Branch to conduct the JE LICE as an 'off-line' exam and also to reschedule the date of the JE LICE.

Accordingly, the JE LICE, which was scheduled to be held on 07.04.2019, was postponed. However, it is regrettable to note that, thereafter no date for the JE LICE for the vacancy year 2017-18 is announced by the Recruitment Branch. It is needless to state that due to the inordinate delay in holding the JE LICE, there is a lot of frustration among the candidates aspiring to appear in the same. In the meantime, the JE LICE for the vacancy year 2018-19 has also become due.

Further, we also wish to submit that the Management is fixing an examination fee for the Internal Exams, even from the Non-Executive to Non-Executive cadres like TT and JE, which are not online exams. BSNLEU has already opposed this exam fee and has already written to the Management, requesting to waive the fee. However, the Management is yet to take a decision on this.

In view of the foregoing, we once again request you to kindly consider to:-

- (1) Hold the JE LICE for the Recruitment Years 2017-18 and 2018-19 without further delay.
- (2) Not to levy any exam fee for the JE LICE.

We shall be very grateful to you if the needful actions are taken expeditiously.
