Sub: - **Insufficient vacancies notified for the JTO LICE to be held on 07.08.2022 - req.**

With reference to the letters cited above, we would like to draw your kind attention to the following.

BSNLEU has already brought to your kind notice that, there are no vacancies in 11 circles for the JTO LICE to be held on 07.08.2022. Further, the vacancies available in 9 more circles are abysmally low. On account of this, the Non-Executives, especially the DR JEs, are a frustrated lot. Hence, BSNLEU is continuously demanding that, the JTO LICE to be held on 07.08.2022 should be held with reasonably sufficient number of posts.

In the meeting held with the CMD BSNL yesterday, it was strongly demanded that, all the JTO posts vacated in 2021, due to JTO to SDE promotions should be included for the forthcoming JTO LICE.

We wish to once again draw your kind attention to the fact that, 945 JTOs were promoted as SDEs through an order issued by the BSNL Corporate Office on 30.12.2021. Through an addendum issued on 01.02.2021, another 127 JTOs were promoted as SDEs. Hence, it was strongly demanded in the meeting held yesterday that, all these 1,072 JTO vacant posts should also be included in the vacancies for the JTO LICE to be conducted on 07.08.2022.

We are grateful that, the CMD BSNL was kind enough to assure that this demand would be seriously looked into. While expressing our thanks for the positive approach of the CMD BSNL on this issue, we fervently appeal to you to kindly ensure that expeditious action is taken on this matter, since the date of the examination is fast approaching.

The Non-Executives, especially the DR JEs, would be motivated through the positive decision to be taken by the CMD BSNL on this issue, which will further get reflected in increased productivity by this section of employees.
