Sub: - Intra circle transfer of JEs of NE-II circle - non-implementation of the CGM, NE-II circle order - seeking intervention of the Corporate Office - req.

We would like to draw your kind attention to the following, for favour of necessary action.

In the Formal Meeting held online on 19.06.2021, between the Director (HR) and BSNLEU, the issue of non-implementation of the CGM, NE-II circle order regarding the intra circle transfers of DR JEs, was discussed. The Union pointed out that, considering the hardships being experienced by the JEs, who are posted in the far-flung areas of NE-II circle, the CGM, NE-II circle has put in place instructions for the intra-circle transfers of JEs.

It is important to note that these instructions were issued after detailed discussions held between the CGMT, NE-II circle and the Main Recognised Unions. In the Formal Meeting held with the Director (HR), on 19.06.2021, BSNLEU complained that, the instructions contained in the CGMT, NE-II circle letter no. no.CGMT/NE-II/Admn/Trfs & Postg/Gr. C&D/Vol-II/14-15/68 dated 31.01.2019, are not being implemented.

The Director (HR) was kind enough to assure that the matter would be looked into and all necessary steps would be taken to mitigate the hardships of the JEs posted in the remote areas of NE-II circle. Thereafter, necessary follow up action was taken by the Sr.GM(SR), BSNL CO.

However, we regret to bring to your kind notice that, despite the intervention of the Corporate Office, no meaningful action has been taken by the NE-II circle to transfer the DR JEs who have completed their tenure. Hence, we request you to kindly look into the matter and to take up the same with the CGM, NE-II circle, to give relief to the JEs languishing in the far-flung and remote areas of NE-II circle.
