Sub: - **Non-declaration of the JTO LICE results in Punjab circle- lackadaisical attitude of the Management - seeking your kind intervention – reg.**

We wish to urgently draw your kind attention to the following burning issue.

The results of the JTO LICE, held in Punjab circle for the Vacancy Year-2014-15, has not been declared so far, due to legal wranglings. The issue was discussed more than once with the Director (HR) by BSNLEU, in the Formal Meetings.

As a result of these discussions, a direction was given to the Punjab circle administration to file an MA. This MA has also been filed long back. However, no breakthrough has come.

Hence, once again this matter was discussed seriously between BSNLEU and the Director (HR) in the Formal Meeting held on 10.05.2023. It was assured in that meeting that, BSNL would engage a senior advocate and that, the case would be pursued seriously.

Under these circumstances, the hearing came up in the Court today. Two knowledgeable representatives of BSNLEU were present in the court, to monitor the developments. However, It was disheartening to note that, the BSNL counsel did not at all attend the case today. Moreover, no official of the Punjab circle administration was also present in the court.

Cases listed up to serial no.80 were heard today. Whereas, BSNL's case is listed against serial no.99. The Hon'ble Judges, after hearing the cases listed up to serial no.80, made an announcement in the open court that, they were prepared to hear any urgent case, if at all counsels of both the sides were present in the court. Utilising this opportunity, BSNL's case could have been brought up for hearing. However, BSNL's counsel was not present in the court, to utilise this opportunity.

We need not elaborate the mental agony and financial loss being suffered by the candidates who have appeared in the JTO LICE for the VY-2014-15, but are languishing due to the non-declaration of the results. Even though, the case is getting repeatedly discussed at the Director (HR) level, no relief has come.

Having failed to get any fruitful outcome, we have no other option before us, but to knock your doors for getting justice. We request you to kindly look into the matter and to ensure appropriate action for rendering justice to the Punjab candidates.
